<p>Violation #47. Food & non-food contact surfaces -Observed burned-out/missing light inside 2-door Continental refrigerator, PC#1153238. Replace light bulb/assess light sensor. [This is a repeat violation from 12/13/24 Routine inspection] -Observed unplugged electric serving line PC#0512533. Per PIC, 2 hot wells are not heating properly and the unit is leaking water. Repair/replace. Work order #4496399 dated 01/29/25. CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.</p>
